REQUESTING A PRE-EVALUATION OF COLLEGE CREDITS

IF YOU WOULD LIKE A PRE-EVALUATION OF YOUR COLLEGE TRANSCRIPTS TO DETERMINE IF YOU ARE MEETING OR HAVE MET THE EDUCATION REQUIREMENTS TO SIT FOR THE CPA EXAM AS A KANSAS CANDIDATE, OR FOR A TRANSFER OF GRADES, PLEASE SUBMIT THE FOLLOWING TO THE BOARD OF ACCOUNTANCY:

- 1. PHOTOCOPIES OF OFFICIAL COLLEGE TRANSCRIPTS FOR ALL COLLEGES AND UNIVERSITIES ATTENDED. FOR INSTANCE, IF YOU ATTENDED MORE THAN ONE COLLEGE OR UNIVERSITY (THIS INCLUDES JUNIOR COLLEGES), THEN YOU MUST SUBMIT A TRANSCRIPT FOR EACH ONE. (DO NOT SEND ORIGINALS). (IF YOU ATTENDED AN OUT OF STATE COLLEGE, PLEASE PROVIDE COPIES OF BOTH SIDES OF THE TRANSCRIPT.)
- 2. PROVIDE AN E-MAIL ADDRESS, TELEPHONE NUMBER AND MAILING ADDRESS.

NOTE: ALL FOREIGN TRANSCRIPTS MUST BE EVALUATED BY A FOREIGN CREDENTIALING EVALUATION SERVICE ACCEPTED BY THE BOARD. THE ONLY FOREIGN EVALUATION SERVICE THAT WE ACCEPT IS NASBA.
